Use of certification date expired Safety Harnesses in SoloSport

Lapping and Time Attack - the expiration date as per the FIA and SFI Certifications apply.... ie: SFI certified harnesses expire two (2) years from date of manufacture as indicated on the label attached to each part of the harness and FIA certified harnesses expire on the date indicated on the label attached to each part of the harness.

AutoSlalom only

1. <u>Prepared and Modified categories</u> - the expiration date as per the FIA and SFI Certifications apply.... ie: SFI certified harnesses expire two (2) years from date of manufacture as indicated on the label attached to each part of the harness and











FIA certified harnesses expire on the date indicated on the label attached to each part of the harness.

- 2. <u>For all other categories</u> It is highly recommended that harnesses are not utilized past their expiration date. Harnesses shall be in good condition (no cuts, abrasions, abnormal wear, etc.).
- 3. In all categories Harnesses if used must be installed properly as per Section 5.3 of the National AutoSlalom Regulations.

Bearings, hubs properly adjusted within manufacturer's specifications, cotter pins or locking devices secure	
General condition of system: springs, shocks, bushings, frame attachments, anti sway bar mounting

Wheels and tire valves: in good visual condition with no apparent cracks	
All studs/nuts: present & fully threaded for secure attachment	
Tires: no cord showing, no cuts, no interference with body throughout range of motion	
uel System	Checked&C
Gas tank or fuel cell: no leaks, attachment secure, filler cap and vent cap present	
Fuel lines: in good condition, no leaks or structural corrosion	
Fuel filter(s): clamps on flex hose, no cracks or leaks	
Fuel delivery lines from tank: no leaks, secure routing	
Carburettor, fuel injection systems, injectors: no leaks	
xhaust System	Checked&C
Flanges, hangers and brackets securely mounted	
The exhaust system must not leak at pipe flanges or joints	
Exhaust pipe must terminate to the side or rear of the car	
Vehicle sound levels within limits of the event
